Poverty Proofing Charter 2022

This charter has been created in response to findings from the Poverty Proofing audit which took place in July 2021. It has been developed through consultation with professionals, specifically with expertise in supporting disadvantaged children, as well as parents, teachers and pupils who were all spoken to or had the opportunity to share their thoughts during the audit.

The purpose of the charter is to ensure a consistent approach throughout school, so that no child feels stigmatised or excluded regardless of their background or socio-economic status.

All children will have access to the full curriculum (both academic and beyond) to meet their needs in a positive and equitable learning environment.

	Trips			
Spending money on trips	Children should not bring spending money on trips	The purpose of the trip is for the experience and learning opportunity that it offers. By not permitting spending money children will still have the same experience/ learning but prevents any child feeling isolated or inadvertently placing pressure on families.		
Cost of trips	Trips costs will all be capped at £5	We recognise that trips can be expensive for families and can add financial pressure so by supplementing the cost we hope to make it more manageable for all. Families in receipt of pupil premium with have the cost covered entirely.		
Publishing trips in advance	We will ensure that parents are notified of upcoming trips in advance (approximately 4 weeks).	This is to ensure that families are able to plan for the expense, especially where larger families have multiple children/ siblings.

Gifts from teachers	All children will be gifted a book at the end of Autumn and Summer Term.	We recognise that buying books may be difficult for some families and that reading is of highest importance to learning and development. By gifting books we can ensure that all children have books in their home and also means there is consistency throughout school without the

Gifts for teachers	Teachers will thank pupils for gifts personally without drawing attention to presents received. Teachers will not share social media posts displaying or drawing attention to gifts they have received. Children will have an inflatables activity day and will be provided with a leavers t- shirt to wear in place of their uniform. End of term/ year parties	Any donations (such as to bring in food) will be collected as a whole. All children will share what has been collected. Children discussing or being asked what they did in the holiday	Instead of whole class discussions, where possible, teachers will have personal discussions with children to ask who they spent time with as a conversation opener rather than what they did. Children will not be asked to write about what they did in the holiday. Pupil birthdays	Pupils are not permitted to bring in cakes or party items/ food for birthdays. All children will be given a birthday badge to wear for the day and sang to in class. Party invitations should not be handed out during school time.	Some families are able to afford and send in large items to celebrate birthdays where others are not. By ensuring all have the same we eliminate children feeling inferior on their birthdays or parents feeling pressured to meet the same standard.

Not all children have the money to purchase the items and may therefore feel excluded. By raising awareness of the charities work we are still supporting them without children feeling pressure to make a donation.
World book day	World book day will be in school uniform and will be orientated around activities that develop and promote a love of learning.	World book day dressing up places pressure on families to purchase a costume, for a single day and does often not contribute to a child's enjoyment or understanding of the importance of reading. This can mean that children do not attend or feel excluded and consequently do not engage in the purpose of the day – to promote a love of reading.
School fayres	All children will be given a set number of raffle tickets so that they can attend the fayre and participate in the games.	All children will be able to enjoy the fayre without exclusion.

School uniform/ p.e kit	No child will miss out on a learning experience because they have incorrect or no kit/ uniform. Names of children will be noted by the class teacher and shared with phase leaders/ office staff to send a letter offering support options for getting the correct uniform. A supply of uniform and P.E kits will be stored in the phase leaders room for children to access and change into if needed.	All children will receive the relevant curriculum learning regardless of their ability to purchase uniform/ kit. Families will be supported to ensure that their child has the correct attire in school in line with the school's high expectations.

Homework	Homework will be limited to spellings, times tables and reading throughout school. Chn in Years 5 and 6 to receive flipped learning homework. Children should not receive a sanction for not completing homework. Instead a record should be kept and support explored with the family on an individual basis.	Not all children have the space, accessibility or support for homework. Through home learning (lockdown) we saw the greatest parental engagement with times tables and spelling which do not require space or additional resources. Reading books are provided by the school at a level which should be accessible to the pupil independently so that little support is required.
